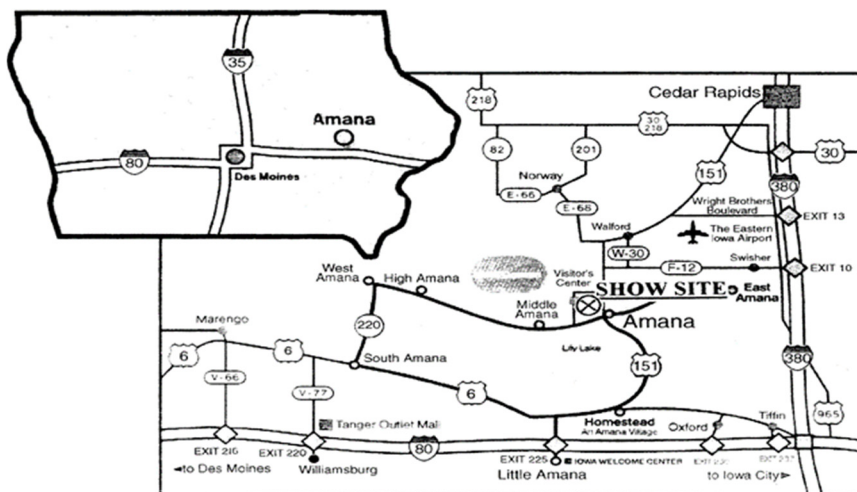

# JUNIOR SHOWMANSHIP COMPETITION

**Novice Junior 9 & under 12 yrs • Open Junior 9 & under 12 yrs**

**Novice Intermediate 12 & under 15 yrs • Open Intermediate 12 & under 15 yrs**

**Novice Senior 15 & under 18 yrs • Open Senior 15 & under 18 yrs**

## **Master Class**

**Novice Class** - shall be for boys and girls who are at least 9 years old and under 18 years old on the day of the show and who at the time entries close have not won three (3) first place awards, with competition present, in a Novice Class. A first place in Novice without competition leading to a Best Junior award with competition would count as one win towards moving to Open at a licensed or member show. Junior Handlers who win a third Novice Class with competition, if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open, after the closing of entries for a show are required to transfer their entry from the Novice Class to the Open Class by notifying the Superintendent or Show Secretary prior to the judging of the class at the show.

**Open Class** - shall be for boys and girls who are at least 9 years old and under 18 years old on the day of the show and who have won three (3) first place awards in a Novice Class or if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open in a licensed or member show.

**Master Class** - will be for boys & girls who are at least 9 years old and under 18 years on the day of the show, and who have won 10 Best Junior wins with competition. The calendar for this class will be consistent with the eligibility dates for the AKC National Championship. All Juniors meeting the criteria for this class are required to enter the Master Class and must change their entry the day of the show if entries have already closed. Once the eligibility time frame for that year has passed all participants return to the Open Class to compete for the following year.

No entry may be changed or cancelled unless notice of the change or cancellation is received in writing by the Superintendent or Show Secretary named in the premium list to receive entries, prior to the closing date and hour for entries, except that a correction may be made from one age division to another, as well as, move from Master to Open or Open to Novice if a win has been disallowed or the Junior miscalculated number of placements, provided this transfer is made by the Superintendent or Show Secretary prior to the judging of the class at the show.

**NOTICE: Junior Handlers must include their AKC JUNIOR HANDLER NUMBER on each entry.**

Pre-entries will be able to choose ribbon colors and have their rosette personalized.

All entries will receive a similar rosette regardless of day of or pre-entry.

Pre Entry - limited to fifteen, closes at time of regular all breed show closing, August 12<sup>th</sup>, at noon.

Day of entry available but limited to total (pre and day of) to 20 participants.

ALL ENTRIES (day of and pre-entries) must sign the release and proper paperwork at the show office prior to participating!!!

Consult judging program for ring time and location.

The Pee Wee Special Attraction is a pre-Junior Showmanship class. The Pee Wee class is geared toward children 5 to under 9 years of age at all shows offering Pee Wee. Each Pee Wee unit consists of the child, his/her parent/guardian/responsible adult, and the dog or a stuffed animal. Only one Pee Wee unit is in the ring at a time. This is not a competitive class, but rather a fun, learning experience for the child and the adult.

- A dog must be at least four months of age to enter the Pee Wee class.
- Bitches in season will not be allowed to participate. If pre-entered, a dog may be substituted that meets the eligibility requirements as specified by the club.
- All dogs entered must have the proper lead and collar.
- A responsible adult must be present with the child both inside and outside the ring. The adult shall to maintain control of the dog outside of the ring.
- At an All-Breed event, all AKC fully recognized and Miscellaneous Class breeds are allowed to enter, including dogs with a PAL listing.
- In addition to an entry, a release must be signed by the child's parent or legal guardian. All pre-entries must come to the club office and sign the release prior to participating. Forms will be available at the show office

The safety of both the dogs and Juniors inside and outside the ring is a primary concern. Outside of the ring, the dog is to be controlled by the adult accompanying the child. An additional lead, provided by the Club, will be at the Judge's table. At the Judge's discretion based upon the size of the child and the dog, for safety purposes the adult may be asked to attach a second lead to the dog so both child and adult will walk the dog together.

Although the word "judge" will be used, this is designed to be a learning and mentoring experience—no Junior will be "judged" but rather will be mentored with the age appropriate amount of information to help prepare them for what they will be expected to know about AKC regular Junior Showmanship once they reach 9 years of age. The children will be mentored one child, their adult, and dog in the ring at a time. Each child will receive a participation rosette and each dog will receive a squeaky toy to commemorate the experience!

The Judge should explain the process of showing the dog to the Junior and the responsible adult in the ring including breed specific presentation. Depending on the size of the dog and the child, the adult may be asked to put the dog on and off the table or ramp, the Club may mandate that the adult should do it regardless. Neither the child or the adult should be asked to show the bite.

Each participant will be given a rosette, bag with lots of goodies and toys, valued at \$20, by the Cedar Rapids Kennel Association.

**Section 1- Classifications**

The Four-to-Six Month Puppy competition shall be for dogs that are four months of age and over but under six months on the day of the event. Classes will be offered for breeds and varieties and divided into Groups as described in Chapter 3, Section 1 of the *Rules Applying to Dog Shows* and the Miscellaneous Class breeds as listed in Chapter 3, Section 23. The Miscellaneous class competition will be the equivalent of Group competition and the winner will be eligible to compete in Best Four-to-Six Month Puppy in Show. The FSS competition will be the equivalent of Group competition and the winner will be eligible to compete in Best Four-to-Six Month Puppy in Show.

**Section 2 – Entry and Eligibility**

Entry and eligibility requirements include:

- The Four-to-Six Month Puppy event may be offered at licensed or member dog shows at the option of the show giving club.
- Four-to-Six Month Puppy Competition must be listed in the premium list, entry form and judging schedule, if offered.
- AKC registration number or an AKC litter number will be required for all entries of an AKC recognized breed as listed in Chapter 3, Section 1 of the *Rules Applying to Dog Shows*.
- A foreign born dog may enter this class if they are registered in the country of origin.
- FSS number or FSS registered litter number will be required for Miscellaneous and FSS breed entries.
- All entrants are to be vaccinated (including rabies) in accordance with their veterinarian's protocol.
- Dogs that are owned or co-owned by a professional handler may compete in this class, but must be handled by a non-professional handler. *Professional handlers are defined as any person who belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay within the last five years. Dogs may not be exhibited by current assistants and household members of a professional handler.*

**Entries will close Wednesday Noon, August 12, 2026** at Superintendent's office.
